Dear Members,

We are pleased to inform you that **the Indian Silk Export Council** is organizing Mega Silk Exhibition & **Buyer Seller Meet at Istanbul and Antalya in Turkey** for display of Silk & other silk allied products including Silk Carpets from 7-12 January 2022, in association with the concerned Indian Mission and with the active support of local Trade Bodies, Chamber of Commerce to develop exports of Silk & Silk blend and other Textile products to Turkey, which is an emerging market in the EU region. The participation of Indian companies in the exhibition cum BSM in Turkey is supported by Ministries of Textiles, Ministry of Commerce & Industry, under the MAI Scheme of Govt. of India.

Participation fee : Rs.7,500/- per participants as per MAI revised Guidelines (subsidized price)

Facility : Highly subsidized participation, display table/booth, 1 night Hotel stays at each

BSM venue on twin sharing basis including 1 breakfast and 1 working lunch

Visa assistance : The Council will provide recommendation letters in respect of the traveling

Managerial Position

In connection with your participation in Mega Silk Exhibition and Buyer Seller Meet in Turkey, kindly note the following:

- The participation will be limited to 30 member companies who have completed 14 months of membership with upto date payment, having export performance in preceding year. The stand/display tables are heavily subsidized under MAI Scheme of Ministry of Commerce and preference will be given to SC/ST/young/ Women Entrepreneurs, start-ups.
- Any extra requirements in stands will have to be borne by the participants themselves;
- One company will be allocated one highly subsidized display booth only;
- Amount of participation charge doesn't include any expenses of representative/s of participants companies like airfare, visa charges, freight, transfer, covid vaccine and RTPCR/Rapid Antingen test charges, if applicable in visiting cities of BSMs country etc;
- A small common pool of Interpreters will be made available at Council's information booth for helping exhibiting participants and visiting buyers. However, for an independent service of an interpreter, participants will have to use their own interpreters; if so desired.
- Participants will be provided visa recommendation letter (if so desired) in obtaining the Visa;
- **Publicity & Promotion:** The event will be publicized extensively by the ISEPC. The Council will also publicize the Fair suitably through a separate Exhibitors Catalogue, sending invites to relevant textile importers in Turkey and adjoining economy, coordinate with the Indian Missions to promote the event to the leading importers of textiles & clothing, among other publicity measures.

Financial Grant:

- As ISEPC is organizing participation of member-companies in Mega Silk Exhibition & Buyer Seller Meet at Turkey under the revised MAI Scheme 2021 of Govt of India, all eligible participating companies have been offered MAI subsidy for reduced amount of participation charge as above, subject to the fulfillment of certain conditions.
- ISEPC will provide to all eligible participants re-imbursement of costs of 2-way airfares, subject to the fulfillment of certain conditions. The reimbursement of cost of economy class airfare to eligible participants will be limited with a maximum ceiling, subject to approval of the Department of Commerce, Ministry of Commerce & Industry, under the revised MAI Scheme.

Criteria for availing reimbursement of airfare:

- Reimbursement of airfare is eligible to the exporting company as per the revised MAI Guidelines and should have exporter performance, having the export turnover below Rs.50 crores (FOB value) in the preceding financial year, subject to furnishing of required documents and approval of the same by the Govt. of India;
- Members to have completed 14 months of Membership with No outstanding dues;
- It is permissible only to the regular **Director / Partner/ Proprietor or a regular officer of the company on Senior Managerial Position** (not admissible to a foreign national or a foreign passport holder);
- Travel Claim forms duly filled in and complete in all respects together with all documents as per MAI Guidelines, must be submitted to the Council within 15 days of completion of event;
- <u>Initial Application form for claiming re-imbursement of airfare should reach to Council 14 days prior to your departure date;</u>

Conditions for availing MAI subsidy:

- A member exporter can avail MAI benefit for participation in 3 approved events in a financial year. 4th time participation in the Fair will be allowed without MAI subsidy. In the case of member belonging to SC/ST/Young/ Women entrepreneur and the exporters' having FOB value of exports of or less than Rs.50 crore in the preceding year, **5 participations in a year is allowed**, provided each one of these is in different market (e.g. Africa, LAC, WANA, ASEAN, etc);
- An exporter can claim MAI benefit for participation in one booth only. Additional booths can be booked by the member participant without MAI benefit (One booth per company only for MAI **eligibility with updated IEC)**; **please attach a copy**
- A maximum of three participations in a particular trade fair/exhibition would only be eligible for MAI assistance, i.e., members who have availed assistance three times (including past cases) for a particular fair/exhibition, from any other EPCs/ Trade Bodies, thereafter, must participate in that fair through non subsidized booth;
- Participants will be selected on a "First-come-first-Served" basis by the Competent Authority.

Last date of confirmation of participation is 3:00 pm on 15th December 2021.

Apply for participation: Exporters registered with EPCs can apply for participation with valid membership. Members interested in the above event are requested to kindly fill up and submit the **"Application Form"** together with a copy of updated and valid IEC copy with participation fee by way of Demand Draft/Cheque at par in favor of **"The Indian Silk Export Promotion Council**, payable at New Delhi. Incomplete application will be rejected. The payment can also be sent through RTGS/NEFT as per the Bank details:
