- Export Performance Certificates for duty free import;
- Market Access Initiatives (MAI) subsidized cost of industry participation in Domestic and International Fairs / Exhibition / BSMs / Potential Market studies;
- > Duty Drawback & RoSL/RoSCTL, MEIS are being distributed by the respective departments of Govt. of India to the Silk and other allied Silk Products on the basis of data submitted by ISEPC;
- Products (RoDTEP) to boost exports to international markets which is a WTO compliant Scheme. The Govt. will reimburse taxes/duties/levies at the Central, State, Local level, which are not currently not being refund.
- > We have lined up activities throughout the Fiscal Year 2020-21 as under;
- Exporters shall be participating in a series of National and International Fairs in countries such as Global Sources at Hong Kong in October 2020, India Trend Fair in Tokyo in July 2020; Sourcing at Magic Fair in Las Vegas in August 2020, Apparel Textile Sourcing in Canada in August 2020. Besides, the exporters will also participate in Who's Next in Paris in September 2020, TEXWORLD USA in New York in January 2021, International Apparel & Textiles Fair (IATF) in UAE, and India Expo cum BSM in Australia, Brazil, Turkey, Cyprus, Greece, Poland in the next year.
- The Council organizing participation in 8th Edition of India International Silk Fair cum RBSM and also participating in Textiles India 2020 scheduled to be held in July 2020 at Greater Noida. Intend to invite overseas buyers from the eligible countries including from developed markets to have one to one business meetings. The registered Member exporters have the privilege to nominate their favorite Buyers (not Indian Passport Holder) and forward the names to the Council for inviting them in our 8th edition of India International Silk Fair cum RBSM in the month of July 2020.
