Chapter I Rules for Election of Members of the Committee of Administration.

Sr. No	Heading	Description		
1	Short Title	These rules may be called the Election Rules, 2020		
2	Definitions	All words and expressions used in these rules shall have the same meaning as those assigned to them respectively in the Articles of Association of the Council.		
3	Persons entitled	Right to Vote etc confined to ordinary members		
	to contest the Election and vote	1. The Members should be a Registered Member of the Council since last financial year, I whose names appear in the Register of Members and who have no arrears of subscription or other dues or charges payable by them to the Council on or before 31/08/2020 shall have the right to vote at, or, subject to the provisions of sub rule (2) of this rule, to offer themselves as candidates at election to various positions (including membership of the Committee) in the Council.  2. A candidate for election to any position, in the		
		Council, must satisfy the following eligibility criteria, namely:  (i) Only an Ordinary Member shall have the right to vote, or to offer-self as a candidate at elections for to various positions in the Council;  (ii) "He or she entity represented by him, must have to his credit, during the one financial year immediately preceding exports of the products of not less than Rs. 10 lakhs and should be a Registered Member of the Council for at least one year;  (iii) Where a person is standing for election as Vice-Chairman or Regional Chairman etc. He / She or the entity, represented by him/her, must have, to his/her or its credit, during the last financial year, immediately preceding, exports of the product of not less than Rs. 10 lakhs.		
4	Number of elected Members of the Council	There shall be twenty elected members of the Committee.		

# 5 Reservations as per Memorandum and Articles of Association

Article 27.8 provides that Election to the Committee shall be conducted every two years, well before the expiry of the term of the retiring members.

Article 27.7 provides that one third of the elected members of the Committee shall automatically retire on completion of 2 years in every election and seniors are to retire first.

Article 27.4 provides the seats for the elected member of the Committee shall be reserved to ensure, as far as practicable, proper representation to the four regions of the country as under:-

7	Procedure of Election	1. The time, date and venue for holding the election shall be notified by the Chairman ISEPC as empowered by the CoA in its last meeting held on 10th July 2020 at New Delhi;

The Chairman ISEPC (as empowered in the last CoA held on 10/07/2020) shall also appoint a Returning Officer who shall be responsible for the conduct of election including receipt and scrutiny of nominations, preparation of the list of eligible contestants, holding election and tabulation of its results etc;		
		3. The Chairman ISEPC (as empowered by the last CoA held on 10 <sup>th</sup> July 2020, shall appoint one or more scrutinizers, who, in the opinion of the Committee can scrutinize the voting and remote e-voting process in a fair and transparent manner;		
		4. The Chairman ISEPC (as empowered by the last CoA held on 10 <sup>th</sup> July 2020 shall write through Council to request MoT / DoC to appoint Govt. Observer well in time for supervising the Elections, whose duties shall be assigned by the concerned Department in MoT & or DoC.		
8	Nominations	1. The Committee at appropriate time shall, call for nominations from the members (including retiring members) who are eligible to contest for election as Vice-Chairman and members of the Committee. Such nominations shall be made in the prescribed form;		
		2. The Committee shall also fix the last date of withdrawal of nominations. Such date shall be not less than 14 days before the date of election. Contestants who wish to withdraw shall intimate their desire to do so in writing in the prescribed form online or offline before the last date fixed for withdrawal;		
		3. The nominations from the intending contestants should be filed online or offline so as to reach the

9	Announcement of Valid nominations	Council by the last date for receipt of nominations fixed by the Committee. This date shall in any event, be not less than 21 days before the date to election;  4. The Chairman ISEPC has been authorised by the CoA in its meeting held on 10.07.2020 unanimously to form and appoint a Committee to supervise the conduct of elections,  5. The Returning Officer shall be responsible for scrutiny of nominations and for this purpose; he may appoint scrutinizers who shall not exceed three in number. The scrutiny of nomination papers shall be taken up immediately after the last date of receipt of nomination papers;  1. The Returning Officer shall, after scrutiny of the nominations, select only valid nominations and categorize them into the categories, indicated in Rule 6 of these rules;  2.
