Please note that this fee does not include airfare, hotel expenditure, sending display material and other related expenditure. We have requested the Govt. for the MAI support which is awaited. Corner Booth Premium Actual fees charged by the organizers will be applicable for corner booth the premium & MAI subsidy is not applicable for corner booth premium. Due to availability of limited number of corner booths, allocation will be done on FCFS basis by Messe Frankfurt, Paris, after considering various aspects as per their own guidelines.

MAI Funding:

This is one of the events proposed by Council for receiving support from Ministry of Commerce under MAI Scheme and awaiting the Ministry's approval. On receipt of the approval from the competent authority the Council shall accordingly arrange to reimburse the subsidy amount applicable and exhibitors are also entitle to seek reimbursement of air fare of economic class travelled with the shortest route under MAI to the eligible member participants, subject to the MAI criteria as under:

(1) Those exporters who have already availed subsidized fee under MAI scheme for 3 or more times including past participation (through any Export Promotion

Council) in this particular event are not eligible to get subsidy under MAI scheme for participation in this edition of Texworld Paris;

- (2) An exporter can avail MAI benefit for participation in a maximum of 3 approved MAI events in a financial year. In case of exporters belonging to SC/ST/Women and the exporters having f.o.b. value of exports of or less than Rs. 50 crores in the preceding year, 5 participation in a year is allowed, provided each one of these is in different market (e.g. Africa, LAC, WANA, ASEAN, etc.);
- (3) Further, the participants who have completed 13 months of membership with the Council and with minimum annual export turnover of Rs. 50 lakhs and up to Rs. 50 crores in the last financial year i.e. in 2024-25 will be eligible to avail reimbursement of air fare of Economy class. Reimbursement of airfare to the companies having nil exports / startups/ new exporters may be allowed up to 10% of the total number of participants, subject to the following conditions:
 - (a) The amount of airfare reimbursed will be 50% of the economy fare, subject to market-wise ceiling prescribed in the scheme guidelines.
 - (b) The exporter has to be active in the domestic market and has at least annual turnover of minimum Rs. 50 lakhs in the preceding financial year. The reimbursement will be upto Rs.90,000/- (economy class air travel) or actual (whichever is less) or a lumpsum amount subject to the final approval and funds received from the Ministry and only applicable to the eligible exhibitors with or above Rs 50 lakhs export performance;
