Eligibility for financial assistance under Market Access Initiative (MAI) revised scheme:

A maximum of three participations in a particular trade fair/ exhibition would only be eligible for MAI assistance, i.e. members who have availed assistance three (3 times) **RPT Three times** (including past cases from any EPCs / Trade Bodies / FIEO) for a particular fair / exhibition thereafter have to participate in that fair on their own. Further, MAI funding support shall only be provided to a member for a maximum of three MAI events in a year in different region. In case of exporter belonging to SC / ST / Women and the exporter is having FoB Value of exports less than Rs. 50 crore in the preceding year, 5 participation in a year is allowed, provided each one of these is in different market (e.g. Africa, LAC, WANA, ASEAN, etc)."

Participation Charges:

The participation charges does not include air-fare, hotel expenditure or any other kind of personal expenses (Logistics etc): It may please be noted that

Eligibility for financial assistance under Market Access Initiative (MAI) scheme shall be governed by the orders of the Ministry of Commerce & Industry. Since this will be a Govt sponsored MAI approved activity for abroad, GST is not being charged on "participation charges" and TDS if deducted should be @ 1 or 2%, since, the Council is leading the role of a coordinator / facilitator, and not receiving the payment as rental.

The Council reserves the right to refuse participation to any applicant, in case not found eligible, as per MAI guidelines or it oversold, without assigning any reason.

Member Companies interested in corner booth are requested to kindly send us a separate cheque in favour of **The Indian Silk Export Promotion Council** payable at New Delhi along with confirmation form. Incase corner booth is not allocated to interested member companies, then their cheque will be returned as it is.

<u>Kindly note the following important points in connection with your participation in</u> <u>Sourcing at Magic at Las Vegas, USA;</u>

- **Any extra requirements** will have to be borne by participants based on actual costs, as set out by the organizer;
- One eligible company as per the revised MAI Guidelines will be allocated one booth of 9 sq mtr (10'X10') only under the subsidized scheme of the Department of Commerce;
- Amount of participation charge doesn't include any expenses of representative/s of participants companies like airfare, lodging and boarding, freight, insurance, visa, expenses, transfer etc.
- Exhibitor Participants will be given Visa Recommendation Letter from the Council for obtaining Visa from the concerned foreign Missions; but preference will be given to valid US visa holders;
- **Publicity & Promotion**: The event is being publicized extensively by the Organizers throughout the world. The Council will also publicize the Fair suitably through a separate Exhibitors Catalogue, sending invites to relevant textile importers in USA and nearby countries and coordinating with the Indian Mission at abroad to promote the event at their level also, to the leading importers / suppliers / renowned international boutique owners / departmental stores of textiles & clothing, high fashion accessories through among other publicity measures.

<u>Criteria for availing reimbursement of airfare as per the MAI Guidelines of Govt. of India</u> to the eligible participants only on approval of the same by Govt:

- **Reimbursement of airfare :** Exporting company having the export turnover below Rs.50 crores (FOB value) in the last financial year;
- Members to have completed 12+months of Membership with this Council and is regularly filing Export returns with us;
- Travel claim is permissible only to the regular Director / Partner/ Proprietor or a regular officer of the company on Senior Managerial Position, (not admissible to a foreign national);
- Attached Travel Claim forms duly filled in and complete in all respects must be submitted to the Council immediately after completion of the event;
- Initial Application form for claiming re-imbursement of airfare should reach to the Council 14 days prior to your departure date to participate in the fair;

Conditions for availing MAI subsidy:

- An exporter can avail MAI benefit for participation in 3 approved events in a financial year, 4th time participation in the Fair will be allowed without MAI subsidy;
- An exporter can claim MAI benefit for participation in one booth only. Additional booths can be booked by the member participant without MAI benefit-One booth per company;
- A maximum of three participations in a particular trade fair / exhibition would only be eligible for MAI assistance, i.e., members who have availed assistance three times (including past cases) for a particular fair/exhibition, from any other EPCs/ Trade Bodies, thereafter, must participate in that fair through non subsidized booth;
- **4** Participants will be selected on a **"First-come-first-Served" basis.**
